

Our School Vision Statement

An Introduction to our School



Coedpenmaen Primary School provides education for children aged three to eleven. In 2024, the school will have approximately 230 students, who currently use 15 different languages to communicate. The school is maintained by the Rhondda Cynon Taff Authority, with oversight from Mrs. Gaynor Davies, the Director of Education.

The school is overseen by the Governing Body, which is made up of parents, teachers, local council representatives, and other appointed community members. It has the responsibility for all decisions concerning the life of the school.

The Headteacher of the school is Miss. Arianne Ansell-Jones.

Most pupils enter the Early Years/Foundation learning section of the school from the Nursery/Reception classrooms. A number of children also join the school in Year 3 upon their transition from Trallwng Infants School. Children then progress through the school and transfer to Ysgol Bro Taf for Year 7, which is the Local Authority designated feeder school. Information with regard to transition to Year 7 will be shared when your child enters Years 5 and 6.

Admissions Policy

Children are admitted to the school in accordance with the current policy of the Local Authority. In line with equal opportunities, academic ability, additional learning needs and criteria other than those listed below are **not** taken into account.

Applying for places at the school:

Parents will need to apply to the local authority, on a form available from the school or the authority or online, for a place for each of their children.

If you have been awarded a place in the Nursery for your child, you will still need to apply again for a place in the following Reception year. Being awarded a place in the Nursery does not guarantee that you will be given a place in Reception.

If your child has been awarded a place in Reception, he/she is then eligible for a place for the rest of their primary years - you will automatically be given a place in Key Stage 2, so will not need to reapply.

If you wish your child to join Coedpenmaen Primary in Year 3 (for example: when leaving Trallwng Infants), or at any other time, you will need to apply for a place as detailed above.

If there are more applications than there are places available, the Local Authority will grant places according to the Welsh Assembly Government approved priorities, detailed below:

- Priority I: Children who are looked after by the local authority.
- Priority 2: Children who live within the catchment, with brothers or sisters (siblings) already in the school (in the year applied for).
- Priority 3: Children who live within the catchment, without siblings already in the school.
- Priority 4: Children who live outside the catchment, with siblings already in the school.
- Priority 5: Children who live outside the catchment, without siblings already in the school.

Where several children within the same category are competing for a smaller number of places, the distance between the child's home and the school will be used as the deciding factor.

Applying to join the school during a school year.

If you wish your child to join the school during the school year, you will need to complete an "in-year" form (available from the school office or Local Authority online). **The Local Authority will decide whether your child can join the school, and will consider**

Start of the School Session and Lesson Time

School starts at 9 o'clock. Children are able to enter their classrooms from 8.50am, where a teacher will meet them and they will be able to settle and start morning activities. There is a 15 minutes break each morning. We request that no child be brought or picked up from school by anyone under the age of **sixteen.**

At the start of the school day, children should arrive in school no earlier than 8.50am. We request that an adult brings your child to school and collects them at the end of the school day. Pupils from Year 3 up are allowed to walk home from school without an adult as long as parental permission has been given beforehand. Children in the Nursery to Year 2 classes will not be dismissed until eye-to-eye contact is made with a known adult. As the children progress through the school, they will be dismissed from class and asked to return if no adult is there for them. If you think you may occasionally be late collecting your child from school, please let us know so that supervision can be arranged.

Attendance

It is essential that your child attends school every day, even in Primary School. Our school target for attendance is 92% for every child. The school follows Local Authority advice for all aspects of attendance. As a result, children falling below these levels may be referred to the Attendance and Wellbeing Service. Continued bouts of illness may also require Medical Certificates.

Holiday Requests

'Missing IO days of school each year = almost I whole year of school lost by the age of I6.'
Please do not ask for leave for family holiday in term time if you can avoid this. If you do you have to ask for permission to take your child out of school for a holiday, please complete an absence advice form (available from the school office) at least two weeks prior to the holiday.

Schools do not have to agree to absence for a holiday. Following Local Authority guidance, Coedpenmaen Primary School continues to adopt a firm approach to requests for holidays in term time

'Holidays are fine - but not in term time'.

The Governing Body at Coedpenmaen has agreed with RCT guidance and, as such, families may be referred for a Fixed Penalty Notice for holiday absence. Please see the Attendance Policy (available on Website) for full details.

If your child is unwell

If your child is unwell, please call the school office (01443 486828) on the first day of sickness. This will ensure our records are up-to-date and that we hold an accurate attendance record. If your child has sickness or diarrhoea they must not return to school for at least 48 hours after symptoms are clear.

Please make sure that we have up-to-date telephone numbers where we can contact you if your child becomes ill, or has an accident, at school. **If your child has more frequent or daily medical needs** please speak to a member of staff – we may be able to support you in ensuring your child's enjoyment of school is not affected too greatly.

If regular illnesses become a cause of concern and adversely affect your child's attendance, we may contact you to discuss any support we can offer, and may ask for evidence of visits to the hospital / doctors etc. so that our records can be kept up-to-date.

Health

If your child has any medical problems e.g. hearing or speech difficulties or conditions such as asthma or epilepsy, it is **very** important that you tell us. Inhalers and other medicines are kept securely in school. The school must be informed if your child has a communicable illness (e.g. chicken pox). You will need to check with your doctor or the school office for how long you need to keep your child at home.

From time to time your child may be offered medical examinations by the school nurse. You will receive prior notice of these appointments. We ask that parents regularly check their children's hair for head lice and treat when necessary.

Medicine

If your child needs prescribed medicine, please give them to your child before or after school. If it is necessary to administer further doses during school time, i.e. medicine to be taken four times a day, the medicine **MUST** be brought to school by an adult where the appropriate permissions forms will be completed.

It remains the parents' responsibility to ensure that all medicines kept at school are within date.

Parental Involvement

Parents play a vital role in the health, wellbeing and education of their children. We aim to foster good relationships between school and home - as outlined in a variety of aspects in this brochure.

There are also other occasions in the life of the school when the help of parents is invaluable (e.g. parents accompany pupils on school trips or regularly listen to pupils read.) We are always grateful for parental help and hope that you will continue such support in the future.

If you have any queries regarding your child's school day, or have any concerns, this should be addressed initially to the class teacher. Teaching staff are available 10 minutes before school starts, or at the end of the school day. Appointments are also available if required.

The school welcomes visits by parents and the Headteacher will normally see them at any time during the day. At times, it may be necessary to make an appointment. This can be arranged with the school office.

Communication is also available through the school's 'Class Dojo', Facebook and Twitter. 'Amser Teulu' Book looks take place termly for you to meet with your child and view the progress they are making in their school books. Parents are invited to attend Parent Evenings to discuss their child's progress. These take place in the Autumn Term and the Spring Term.

Parent Council

The Parent Council is a body of parents nominated by parents of pupils at Coedpenmaen Primary School to represent parents and carers. It provides a forum for them to put forward the views of the parent/carer community and to provide feedback that may enhance the smooth running of the school.

The Parent Council works in partnership with the school to:

- Support school decisions
- Share ideas between school and parents/carers
- Enhance communication between Coedpenmaen Primary School and the parent/carer community thus improving parent voice and subsequent feedback to the parent/carer community.

Coedpenmaen Primary School PTA

We have a wonderful active PTA (Parent Teacher Association) who have been instrumental in making changes across our school, including outdoor reading sheds and the paintings and markings to both of our playgrounds. School Newsletters

Newsletters are regularly sent to parents informing them of events and activities. These newsletters are shared on our Class Dojo, our school Facebook page and our school X account.

Pastoral Care

The Headteacher (or Deputy Headteacher in her absence), in conjunction with all staff at the school, has responsibility for the welfare and safety of each child, with our focus supporting the wellbeing of all. A happy child is one who will enjoy learning. Children in Local Authority Care are welcomed and supported throughout their time with us at Coedpenmaen. The staff are always ready to discuss any problems a child may be experiencing. Parents and carers should not hesitate to contact school if they are worried about their child; likewise we will inform you if we have any concerns.

Children Looked After (CLA)

Children and young people become 'Looked After' either if they have been taken into care by the local authority, or have been accommodated by the local authority (a voluntary care arrangement). Most Children Looked After live with foster parents but a small number may be in children's residential units, living with a relative or even be placed at home with their birth parents. The Deputy Headteacher Mrs B Griffiths is the school's designated officer for CLA and acts as a source of advice and support to other school staff. In her absence this role is taken by Miss A Ansell-Jones (Headteacher). A Personal Education Plan(PEP) is put in place for CLA pupils.

Health and Safety

The health and safety of the children in our school are of utmost importance to all who work here. We encourage children to become safety conscious from the early years. Therefore, we ask parents to assist us by ensuring that children only wear <u>stud earrings</u> and <u>no platform type shoes</u>, in order to avoid unnecessary accidents occurring in school. <u>All</u> jewellery must be removed for PE sessions. The local fire station and police also visit the school to talk about dangers in the home and outside.

We request that parents and carers park considerately when bringing and collecting your child as inconsiderate parking may jeopardise our children's safety. The school is surrounded by a fence with a number of access points at the beginning and end of the day. During the school day there is only one entry point, at the front of the school, through security-controlled processes at the office.

For the safety of pupils and adults in the school, we operate the following procedures:

- ➤ All visitors must report to the main office, sign in, and wear a visitor badge.
- The playground gates are locked at 9:10am on school days late children will need to be brought around to the main gate, and come in through the office. They are re-opened at 3.00pm.
- > Parents may not drop off children from cars in the front car park for breakfast club.
- > External doors are part of a whole school fob system.
- > Please do not bring dogs, except guide dogs, onto the premises.
- ➤ Please do not park on the yellow lines on Llanover Road above the school, or Coedpenmaen Close at the front of the school this puts children at risk. The community police service occasionally patrols the area.

Equal Opportunities

Coedpenmaen Primary School is committed to equality of opportunity for all its pupil regardless of sex, gender, race, religion, sexuality or social class. We want all our pupils to achieve their full potential during their time with us. We believe that all pupils are of equal worth and we place equal value on the abilities, talents and skills of every individual in our charge. We actively plan to make all aspects of the school curriculum equally attractive and accessible to all. A copy of the Strategic Equality Plan is available on request.

At our school there is a full programme of extra-curricular activities which are rotated and pupils are encouraged to participate in this important part of school life. The following clubs are available at our school throughout the year:

Recorder / Sports / Netball / GLEE / Art/ Film/STEM/Traditional Crafts/Rugby/Cricket/

As well as the above activities, older children have the opportunity to receive violin, piano, guitar, drums, and singing tuition on a weekly basis.

Swimming instruction takes place for all pupils from Year 3. Our sports teams regularly take part in matches against other local schools and further afield and have gained much success.



Curriculum for Wales

Curriculum for Wales has been developed with education professionals across Wales which gives schools some flexibility in determining how and when they approach it's teaching.

4 Purposes

The 4 purposes are at the heart of the new curriculum. They are the starting point for all decisions on the content and experiences developed as part of the curriculum to support all children and young people to be:

- ambitious, capable learners ready to learn throughout their lives.
- enterprising, creative contributors, ready to play a full part in life and work.
- ethical, informed citizens of Wales and the world.
- healthy, confident individuals, ready to lead fulfilling lives as valued members of society.

Key Elements

The new curriculum includes:

- 6 Areas of Learning and Experience from 3 to 16.
- 3 cross curricular responsibilities: Literacy, Numeracy and Digital Competence.
- Progression reference points at ages 5, 8, 11, 14 and 16.
- Achievement outcomes which describe expected achievements at each progression reference point.

The curriculum is organised into 6 Areas of Learning and Experience:

- Expressive arts.
- Health and Well-being.
- Humanities (including RVE which should remain compulsory to age 16).
- Languages, Literacy and Communication (including Welsh, which should remain compulsory to age 16).
- Mathematics and Numeracy.
- Science and Technology

Coedpenmaen Primary has whole school themes, with each class taking a different line of enquiry within this. Our themes are reviewed termly and take on board a range of stakeholder views to consider current school, community and world issues to ensure that our curriculum remains authentic and rooted in purpose. We have a topic validation process in place that ensure the class lines of enquiry are progressive and relevant to our learners.

How is your child assessed?

Assessment at Coedpenmaen Primary School takes a variety of forms - both assessment of learning and assessment for learning.

Assessment of learning includes baseline assessments, standardised and personalised tests and termly standardised testing – Salford/Malt/Schonell assessments. These results are used to plan further learning and identify any gaps in teaching. Assessment for learning is the continuous process of finding out where children are in their learning, where they need to go and how best to get there.

Early Years Assessments

Teachers assess pupils throughout the time they are in our school. In the Early Years these are known as Baseline Assessments and they monitor how our pupils are doing in basic Literacy, Numeracy and Personal and Social skills. A baseline assessment is completed within the first 6 weeks of full-time education.

Teacher assessment

Teacher assessment is a continuous process. Teachers informally assess children whenever they teach a class, as well as when they mark a child's work, listen to them read or discuss their work with them. An effective Feedback policy is in place and is consistently used across the school.

All children in Wales from Year 2 to 6 are required to sit personalised standardised tests in reading, mathematics and mathematical reasoning. These are used to support the tracking of progress, the outcome of which is shared with parents and carers.

Annual Reports are sent home at the end of every school year and arrangements are made for parents to discuss these with the teachers. We are currently trialling a new format for our reporting to parents and are engaging in a Pupil Progress Pilot Project for this academic year.

Parents of all pupils are invited to "Meet the Teacher" early in the Autumn Term and again to parents meetings later in the Autumn Term and again in the Spring Term. However parents have the right to see records kept concerning their child's progress throughout the year.

Swimming

Pupils from Years 3-6 take part in swimming lessons. These are funded by the local authority. Please note that swimming is an integral part of our Physical Education lessons and pupils are expected to participate. Lessons are delivered by qualified coaches at local swimming pools. Transport is also provided. Girls will need to wear a one piece swimming costume. Information will be posted on Class Dojo before your child's swimming lessons begin.

Breakfast Club

Everyone is welcome to attend our free breakfast club that runs from 8 am until the start of the school day at 8.50 am. Breakfast is given and activities are provided by qualified staff. Door close for breakfast club at 8:30am.

School Rules

Excellent behaviour is an essential part of the ethos of the school. All staff and pupils need to be kept safe from physical and verbal assault and the school has a duty of care in this respect. For effective teaching and learning to take place, excellent behaviour is necessary. For pupils to learn they need a secure environment with a clear framework of behavioural expectations that are consistently implemented.

At Coedpenmaen Primary School, we seek to create an underlying ethos, which will support the development of personal qualities of honesty, trust, perseverance, compassion and responsibility. We all have a responsibility to ensure that our pupils are provided with the best opportunities in order to develop and learn in an ever changing world. We should all aim to accept responsibilities we are given and to endeavour to improve constantly to the betterment of all.

Our School Rules apply to everyone at Coedpenmaen Primary School:

We always use kind words, hands and feet.
We take care of our school and the people in
it.
We respect the right of the teachers to teach.
We respect the right of pupils to learn.

Rewards

At Coedpenmaen Primary School, we use Class Dojo as our positive rewards system. Class Dojo is an online platform which offers many useful features including positive behaviour management, parent/teacher communication and class/ school news feeds. There is a Class Dojo Expectations and Acceptable Use Policy at Coedpenmaen Primary School, which is available on our school website.

Dojo points are to be used to celebrate achievement and effort. Teachers will be encouraged to award Class Dojo points to pupils when they demonstrate positive behaviours or attitudes to learning. It is expected that all children will have a minimum of 25 Dojos a term. When children reach the milestones of 25, 50 and 75 Dojos then they will have a certificate and a house point. When all children in a class reach 25, 50 and 75 Dojos, then a whole class reward will be given. The activity chosen will be at the discretion of the class teacher - This must be inline with our Healthy schools policy. All Dojo points will be reset to 0 on a half termly basis. As we are working to achieve our next Healthy Schools Award – we will **not** be rewarding pupils with chocolate/food or other unhealthy rewards.

Coedpenmaen Primary School House Point System:

At Coedpenmaen Primary School we have a house point system in place. There are four houses linked to our local community which pupils are allocated to on admission to the school.

Ty Coch - Carreg Siglio

The Rocking Stone or 'Y Maen Chwyf' in Welsh is a glacial boulder remaining from the Ice Age. It formed the central point for a 'Gorsedd' or 'Gathering of Bards' in 1814, which was organised by stonemason Edward Williams known as 'Iolo Morganwg'. The Gorsedd Circle of smaller stones was constructed in 1849 by Evan Davies, Bardic name 'Myfyr Morganwg' and has often been used for Bardic gatherings, and as a focal point for other public occasions. The Rocking Stone is on Coedpenmaen Common and was a focal point for public meetings in Pontypridd.

Ty Melyn - Tai Crwyn

The Round Houses were built in 1938-1939 by Dr William Price. The twin Round houses have been an iconic feature of Pontypridd. They were originally intended to form the gateway to a 19th Century museum of Welsh Druidic life, but never fulfilled their intended purpose, as it quickly emerged that Dr Price neither owned the land, nor had permission or finance to build them.

Ty Gwyrdd - Parc Ynysangharad

Ynysangharad War Memorial Park was opened by Field Marshal Viscount Allenby on the 6th August 1923. It features a bandstand, the National Lido of Wales, tennis courts, lawn bowls greens, a football pitch, a cricket pitch and war memorials for Pontypridd and a memorial for the composers of the Welsh National Anthem.

Ty Glas - Yr Hen Bont

The old bridge, which is now known as the William Edwards Bridge or Pontypridd Bridge, was originally known as The New Bridge or Newbridge, is an arched single-span footbridge that spans the River Taff. The bridge was built by William Edwards and completed in 1756. It was so long that it took 4 attempts to get it right. The first wooden bridge was washed away by floods in a storm. The second and third bridges made of stone collapsed during construction because of their weight. The final design was also made of stone but much lighter because it has 6 holes in it... 3 on each side.



House points are awarded for:

- I 00% weekly attendance

There is also a large orange token that can be awarded for 'Outstanding Achievements'. The orange token is then worth 10 house points.



Happy Grams

Happy Grams are positive messages that are sent home.

Restorative Approaches

All staff have been trained in, and are expected to use, Restorative Approaches. This involves building relationships with the children, colleagues, parents and carers, and the wider school community. We also expect staff to use the restorative enquiry to encourage all adults and pupils we are working with, and ourselves, to be reflective, honest and to find a way forward with any issue. Our class charters are developed each year with each new year group, to build our classrooms as communities who care about each other's needs and their own needs and behave with respect for each other. When we have meetings with family members, carers and other agencies, we will adopt a restorative mindset and approach as our first choice wherever possible.

We aim to foster a love of lifelong learning in our pupils, and so all staff, model good relationships, and practice what we preach. We collaborate between ourselves and with the pupil and their learning journey and engage with their families and carers wherever possible to build relationships and engagement in learning. All behavioural incidents and conflicts are opportunities for social and emotional learning at any time, and with children and staff, including lunchtime supervisors and support staff and families/ carers. A restorative response enables children and all adults working with them to work together consistently to build up our learning community.

Specific Sanctions

The Governing Body has agreed that the following 'disciplinary penalties' may be used in the school:

- Engage in Restorative follow-up;
- Removal from the group/class or particular lesson;
- Withdrawal of break or lunchtime privileges;
- Withholding participation in visits or sports events which are not essential to the curriculum;
- Carrying out a useful task in the school;
- Completion of work or extra work (Internal Exclusion);
- Fixed term exclusion; and
- Permanent exclusion;

Pupils with emotional/behavioural difficulties often require very structured, sensitive programmes of behaviour modification. These pupils should be supported by advice from Access and Inclusion services and the Educational Psychology Service.

Positive Handling

Physical Intervention is only used to de-escalate, defuse and divert in order to prevent violence and reduce the risk of injury to staff and pupils. More information can be found in our Restrictive Physical Intervention Policy.

School Uniform

Our uniform is important to us. It shows us that we are a family and all of equal value and worth. Whilst we do not insist on badged uniforms, we encourage all children to choose appropriate clothing from the list below:

Navy blue V Neck Pullover/sweatshirt/cardigan/hoodie - no text beyond the school logo and child's name

Pale Blue or White Shirt / T-shirt / Blouse

Dark Trousers / Skirt / Pinafore slip / Shorts

Blue & White Check Gingham Dress

Dark Socks/Dark Footwear

School Tie - Royal Blue /White Stripes (optional)

PE Requirements

Navy/dark joggers or shorts (weather dependent)/dark sweatshirt, hoodie or sport jacket with no writing/white t-shirt no football tops/ trainers or plimsolls. Jewellery should not be worn at school, the only exception being stud-backed earrings worn.

Optionally layering

Students may wear additional layers (e.g., undershirts, leggings) in solid, neutral colours to accommodate cultural or personal modesty preferences, as long as they match the overall school colours.

Hair/Head

We ask our parents to consider appropriate hair cuts for school and for children to have their natural hair colour and non-extreme styles. As a school we adopt the Halo Code. Students may wear religious or cultural head coverings (e.g. hijabs, turbans, kippahs). Sports hijabs are to be worn for P.E. lessons.



For Schools

Our school champions the right of staff and students to embrace all Afro-hairstyles. We acknowledge that Afro-textured hair is an important part of our Black staff and students' racial, ethnic, cultural, and religious identities, and requires specific styling for hair health and maintenance.

We welcome Afro-textured hair worn in all styles including, but not limited to, afros, locs, twists, braids, cornrows, fades, hair straightened through the application of heat or chemicals, weaves, wigs, headscarves, and wraps.

At this school, we recognise and celebrate our staff and students' identities. We are a community built on an ethos of equality and respect where hair texture and style have no bearing on anyone's ability to succeed.

Additional Learning Needs

Mrs. Beth Griffiths is the Additional Learning Needs Coordinator (ALNCO) for our school and works in collaboration with class teachers, the Headteacher and outside agencies to identify any children whom it is felt have particular educational, social or behavioural needs. For example, if a child needs extra support or, to the contrary, if a child is particularly able and needs to receive extension work.

These children are monitored by class teachers and then, if required an Individual Development Plan (IDP) is written in collaboration with the child and their parent/carer to suit their needs, in line with the new ALN Act.


Children's progress is then monitored regularly, and outside agencies may consequently be called in to assess the child's needs.

Annual reviews are carried out with our Additional Learning Needs Co-ordinator and other specialists along with parents and carers of pupils on the Additional Learning Needs register.

Every effort is made to accommodate children with Additional Learning Needs, and excellent relations are held with local Health Visitors, Access and Inclusion (RCT) and the Educational Psychology Service, who can so often assist the school greatly in such matters .

Mrs. Amanda Hughes is a full time Literacy Support Assistant who works with individuals and groups of children in this area. She and several other support staff also assist in running our literacy intervention programmes which provide extra support to certain pupils.

Mrs Sharon Baggs is our school ELSA who supports pupils with Wellbeing interventions.





Religion, Values and Ethics

RVE sits in the AOLE of Humanities. The RVE taught within our school meets the legal requirements of the R-C-T Agreed Syllabus and the Curriculum for Wales. RVE teaches about a range of faiths, as well as non-religious and philosophical convictions. Our RVE is objective, critical and pluralistic. RVE develops from pupils' own perceptions and experiences. The right to withdraw from this subject is no longer applicable.

Collective Worship.

Regular assemblies are held for a short collective worship and a special celebration assembly is held every week to celebrate pupils' achievements. A variety of people regularly visit our school to lead assembly. These include members from local churches, including Trish Tazzini-Lloyd and Alun Davies. You have the right to withdraw your child from collective worship.

Relationships and Sexuality Education

The School Governors have agreed that the school will follow the Jigsaw scheme of work to support and deliver this area of the curriculum, in addition to the Cwm Taf Healthy Schools resources. This will be reviewed regularly in accordance with Welsh Government advice and Guidance. Copies of our Policy can be obtained from our website.

School Meals

Cooked school dinners are provided from our school kitchen and payment is made in advance and online. As per RCT policy, Universal Free School meals are available for all pupils who attend Coedpenmaen Primary School.

Applications for free school meals are made online through the RCT website. The local authority are able to provide further information regarding eligibility.

Children are also able to bring in packed lunches if you wish. Healthy lunches are encouraged at all times as part of their balanced diet. Drinks in glass bottles/flasks etc. are not allowed. Parents are asked to include items easily consumable to younger children. Unbreakable plastic containers are recommended for safety reasons - no glass containers please. If you wish your child to go home for lunch you must communicate this with us at the beginning of the academic year. Our kitchen staff are also very proud of their food hygiene rating of '5'.

Charges

Coedpenmaen Primary School will always aim to provide learning experiences that are free or accessible for all children. The Governing Body has agreed that the Headteacher may seek voluntary contributions from parents, so that activities during school hours such as educational trips, can continue however discretion is used in order to ensure all children can access these and that family income is never a barrier to learning.

Milk is available daily for every child from Nursery to Year 2 free of charge. In cases where a child has an allergy to milk, an alternative will be provided. It is the responsibility of the parent/carer to inform the school if this is the case so that alternative provision can be sought.



Healthy Eating

We are proud to continue working with the Healthy Schools team. We greatly appreciate your support with this, particularly over break time snacks and drinks. Pupils are encouraged to bring a healthy snack for snack time. Our rule is that children may bring fresh fruit or raw vegetables as a snack, not "fruity" bars, as these contain high sugar levels. We also encourage water to be available to the pupils as they work in class. We kindly ask parents/carers to provide refillable water bottles. Squash/fizzy drinks are not permitted at





At Coedpenmaen Primary School, we feel it is vital to create a secure and safe environment for all children and adults in the school. A Fob system is fitted to all doors to prevent unauthorised visitors entering the school building. All visitors are requested to sign in at reception and agree to the school's safeguarding policy.

Security

All children are well supervised during playtimes and lunchtimes and staff ensure that security gates are closed. Children are asked to report any strangers to the nearest member of staff, who will report any incident to the Headteacher. For additional security to school premises, the school has an alarm system which is monitored at all times.

Disability Access

At Coedpenmaen Primary School we are committed to ensuring equality and equity of education and opportunity for disabled pupils, staff and all those receiving services from the school. We aim to develop a culture of inclusion and diversity in which people feel free to disclose their disability and to participate fully in school life.

Everyone is welcome in our school, and there is good wheelchair access to all areas of the school universal toilet facilities are available, as well as a school stair lift.

We will endeavour to cater for the needs of disabled parents/carers at all times. At Coedpenmaen Primary School we aim to ensure that the learning needs of disabled pupils are fully met within the classroom and outside.

Child Protection/Safeguarding

Coedpenmaen Primary School has the protection and well being of all pupils as its priority. In our school the Headteacher, Miss Ansell-Jones has overall responsibility for child protection matters and acts as a source of advice and support to other staff. Our Deputy Mrs Griffiths deputises in her absence. Our other safeguarding team members are Mrs Walters and Miss Olson. All staff receive annual safeguarding training.

Our school has nominated child protection governor, Cllr Michael Powell who has to ensure that the school has a child protection policy in place which is consistent with the new All Wales Child Protection Procedures, that all staff in the school must follow where there are concerns or suspicions of child abuse.

If we receive or are aware of a safeguarding concern involving a child, we have a duty to refer these to Children's Services and, if necessary, the police without delay. We have no discretion in this matter.

Our first concern as a school is your child's welfare. Where we have general concerns these will be raised with you and we would want to work with you to remedy the situation. However, there may be concerns, as listed above, where we have to talk to other agencies before we contact you. Should this be necessary, we want to reassure you that any concerns we have about your child will then be fully discussed with you in a way which is consistent with your child's best interests.

School Senedd

We have an active School Senedd at Coedpenmaen Primary School made up of all pupils from year 2-6. A Senedd Leader and Senedd Deputy are elected by pupils at the school and Chairperson, Vice Chair and secretary are appointed by their Senedd groups. Our Senedd meet regularly under the supervision of staff at the school.

They discuss a variety of issues about how they can make our school a better place, and allow opportunities for pupil voice. The School Senedd makes regular presentations to the Governing Body.

Medical and Accidents

Please will you ensure that we are informed about any medical condition relating to your child that is likely to affect your child's education or general well being in school. School should be informed if your child would require any emergency medication e.g. EpiPen. (All school staff receive annual EpiPen training).

Please ensure that if your child requires an asthma pump, the school is informed of this and brings their pump into school clearly labelled with their name and class. Also, should your child need medication administered to them, please could you complete a form and discuss with the child's class teacher.

At various stages through the school years, children will have their eyesight and hearing tested and a routine dental check is usually carried out. Any concerns raised during these routine checks will result in the offer of an appointment to the relative health department.

If your child becomes ill or has an accident at school it may become necessary to contact you. Please ensure that emergency contact numbers are up to date. Children who have minor accidents at school, usually when falling over at playtime or lunchtime, are tended to by one of the school's qualified first aiders. These accidents are recorded in the accident book and parents are informed of any significant incident either by means of a note or telephone. If your child has an injury to the head, we will contact you to inform you.

Smoking in School

Governors at this school have agreed a **NO SMOKING POLICY**, which means that smoking or vaping is not allowed in school or at the gate. We would appreciate your co-operation in this matter and ask that you do not smoke or vape either in school or when waiting in the school grounds.



Head Lice

Each year we have cases of head lice in school. The school nurse no longer visits school to inspect children's hair so parents are asked to do this at home on a regular basis.

Letters/messages informing parents that there are cases of head lice in a child's class are routinely placed on Class Dojo.

The occurrence of head lice is regarded as a community problem, generally when a child has head lice, other family members will also be infected. Advice can be sought from the local pharmacist on methods of free treatment.

Cars on School Grounds

There is strictly no parking for parents/carers on the school site. Whilst we encourage all children to walk to school safely, we understand that this may not be practical. We therefore ask that you park in a way that is considerate to our neighbours and safe for children. Parking on the yellow zig zags is strictly prohibited and these areas are regularly monitored by the local traffic wardens.

Mobile Phones

Mobile phones are **not** allowed at school – any child who brings a phone to school are required to hand the phone into the school office for safe keeping until the end of the school day. This includes 'phone' watches.



Dogs on sites

Please do not bring dogs, except guide dogs, onto the premises.





Access to pupils' records

Parents have the right of access to information on pupil records and documents relating to the school's curriculum, on request to the Headteacher. Information related to Subject Access Requests and Education Records Requests is available in the school GDPR policy on request or on the school website.

Complaints Procedure

Any complaints will be dealt with as quickly and sympathetically as possible by the Headteacher. The Governing Body has adopted the RCT Complaints procedure. For more information, the policy is readily available at our school office or on our school website.

Special Events

We hold many special events throughout the school year. These are available in advance on our Class Dojo events section and are detailed in the regular newsletters. We also ensure that the pupils begin to understand their place in the wider world with their active participation in special assemblies for events such as Remembrance Day.

Charity work has a high profile with, for example, the school's involvement in Macmillan Coffee Mornings, Red Nose Day and Children In Need.
